#### Items to be considered for approval

Mayor Lee asked for a motion to approve tonight's agenda with tabling item B under new business, appointment of City Attorney. Councilman Altman made the motion to approve tonight's agenda with tabling item B from new business, Appointment of City Attorney. Mayor Pro-Tem Davis seconded the motion, all in favor, motion carried by 4-0 vote. Voting for the motion are Bruce Davis, Andrew Altman, Crystal Johns, and Deloise Anderson. No councilmember voted against the motion.

Appointment of City Clerk-Councilman Altman made the motion to re-appoint Angela Wirth as the City Clerk for the City of Nahunta for the 2025 year. Councilmember Johns seconded the motion, all in favor, motion carried by 4-0 vote. Voting for the motion are Bruce Davis, Andrew Altman, Crystal Johns, and Deloise Anderson. No councilmember voted against the motion.

2025 Election Qualifying Fees-Councilmember Johns made the motion to approve the 2025-year election qualifying fees of Mayor-\$216.00 and Council-\$108.00.
