Sanitation Increase, January 2025-Tom Wirth informed the Mayor and Council Republic Services will be increasing our sanitation pricing effective January 1, 2025. Residential is currently \$14.48 and will increase to \$15.22 a .74 cent increase and Commercial is currently \$19.90 and will increase to \$20.91 a \$1.01 increase. Crystal Johns made the motion to approve the new increase effective January 1, 2025. Deloise Anderson seconded the motion. Motion carried by 3-0 vote. Voting for the motion are Andrew Altman, Crystal Johns and Deloise Anderson. No Councilmember voted against the motion.
